An Area Agency on Aging as defined by the US Department of Health and Human Services (DHHS), Office of Human Development Services, Administration for Community Living, Administration on Aging (AOA), develops and administers an area plan for a comprehensive and coordinated system of services to persons aged 60 and older.

4b (Code:) (Expenses \$ 213,636. including grants of \$) (Revenue \$) The Agency is designated by the Governor's Office of Elderly Affairs as the Aging and Disability Resource Center (ADRC) for a 13-parish (county) area. The ADRC offers a "one-stop-shop" for public and private programs at the community level that will help individuals who are 60 years and older and individuals with adult onset disabilities.

4c (Code:) (Expenses \$ 649,705. including grants of \$) (Revenue \$) Senior Community Services Employment Program (SCSEP) is a community service and work-based training program for older Americans. Authorized by the Older American Act, the program provides training for low-income, unemployed seniors. Participants also have access to employment assistance through American Job Centers. SCSEP participants gain work experience in a variety of community service activities at non-profit and public facilities, including schools, day-care centers and senior centers.
